

## **SUMMARY ANNUAL REPORT FOR RECREATIONAL EQUIPMENT, INC. GROUP LIFE AND MEDICAL PLAN**

This is a summary of the annual report of the Recreational Equipment, Inc. Group Life and Medical Plan (Employer Identification Number 91-0656890, Plan Number 501) for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Recreational Equipment, Inc. has committed itself to pay certain medical, dental, vision and health FSA (medical, dental and vision) claims incurred under the terms of the plan.

### **Insurance Information**

The plan has insurance contracts with Aetna International, National Union Fire Ins. Co. of Pittsburgh, PA, Hartford Life and Accident, Health and Human Resource Center, Kaiser Foundation Health Plan of Colorado, Kaiser Foundation Health Plan Inc, Kaiser Foundation Health Plan of Washington Options, Inc. and Lincoln National Life Insurance Company to pay certain medical, life, accidental death and dismemberment, dental, vision, long-term disability, business travel accident and employee assistance program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$6,193,095.
